

ANGUILLA IMPORTS SELECTED MEATS AND BY- PRODUCTS 2000-2004

Meats and Poultry



Even though cows, pigs, sheep/goats are slaughtered on the island for consumption by the public. The consumption outweighs the production hence the large quantity of these meats imported.

During the period 2000 – 2004, there were 542,050 kg of beef imported, 561,214 kg of pork and 165,526 kg of mutton imported. 2004 saw 15.0% more in beef importation over 2003, while there was 1.6% more in pork meat products imported.

The quantity of imported whole poultry has been declining since 2000 as is indicated in the table 4, while the quantity of other parts such as wings, backs and necks has been on the rise since 2001, with a slight drop during 2002. 19.5% more in quantity of these parts were imported during 2004 over 2003.

Imports of "Other"¹ parts of the chicken, turkey and duck rose in 2001 over 2002, but began to drop from the period 2002 to 2004.

Animal Feed

There was a 65.4% increase in the quantity of cattle feed imported in 2004 over 2003, while imports of poultry feed dropped a significant 93.0% over the same period. With a number of poultry farms on the island there is a possibility that much of the poultry feed imported in 2003 was still being consumed during 2004 hence the low quantity.

Fish



Although there are many local fishermen on Anguilla who sell their catch at fish markets throughout the island, there is still a vast quantity of fish products being imported mostly by hotels and restaurants.



2004 saw a 16.0% increase in the quantity of fresh and chilled fish coming into the island over 2003, while there was a 23.3% drop in canned fish products and a 30.0% drop in other fish products being imported

Dairy Products



Imports of milk increased 22.4% during 2004 over 2003. Most milk products imported include, cream, powder and condensed milk.

52, 764kg in cheese products were imported in 2004 over 2003. These products include grated, powdered, unfermented and processed cheese.

Most of the island's supermarkets are stocked with locally produced eggs and to some extent imported eggs. The 23,060 kg of imported eggs in 2004 were mainly egg substitute products and to a lesser extent whole eggs.
