VEHICLE IMPORTS 2003 -2004

What are Pick-Ups?

Pick-up trucks are considered light trucks which are often used as passenger cars for everyday driving, but they also provide the ability to carry extra cargo when needed. They are used primarily for light hauling and construction work.

What vehicles are included in Heavy Equipment?

Heavy Equipment includes tractors, loaders, graders, backhoes, excavators, caterpillars, forklifts, trailers, bulldozers and rollers all of which are imported to the island.

Importation of vehicles to Anguilla has increased significantly in 2004 over 2003 by 41.0%. Imports in 2003 were 651 and 2004 there were 918 vehicles imported.

The only type of vehicle imported which did not register an increase in 2004 over 2003 was motorcycles which declined by 40.0%.

Bus/Van imports increased by 108.7%, Pick-ups by 71.4%, Heavy Equipment by 70.6%, Jeeps by 54.9%, Cars by 40.9% and Trucks by 13.3% over their 2003 figures.

Importation of vehicles for the months of January and July in 2004 declined by 41.1% and 12.3% respectively compared to 2003 figures for the same period. The major drop in numbers within these months were due mainly to the decline in the importation of cars.

February, May and June showed increases of 141.7%, 101.4% and 126.3% respectively over 2003 figures for the same period. The other months also showed increases over the 2003 figures. Please note that in May 2004, vehicles were imported on a temporary basis for the Car Show (3 vehicles).

10. Whether intended for
 - (a) Private use
 - (b) Use for trade purposes
 - (c) Use as a public service vehicle
 - (d) Use as a passenger freight vehicle
11. Particulars as to the position on the car in which it is proposed to place the plates forming the identification mark.
